## INDEMNIFICATION AND CONTRIBUTION AGREEMENT

To the fullest extent permitted by law, \_\_\_\_\_ and all of it's sport participants/players (hereinafter referred to as the "Association") agree to indemnify, defend Town of Irondequoit any and all losses, claims, actions, demands, liabilities, or expenses, including but not limited to attorney's fees and all other costs of defense, by reason of the liability imposed by law or otherwise upon Town of Irondequoit for damages because of bodily injuries, including death, at any time resulting therefrom, sustained by any person or persons, including Association's employees and sport participants/players or on account of damages to property, including loss of use thereof, arising directly or indirectly from the performance of Association's work or from any of the acts or omissions on the part of Association, its employees, agents, representatives, materialmen, suppliers, participants, and/or subcontractors. If such indemnity is made void or otherwise indemnity permitted by law, so as to require indemnification, in whole or in part, to the fullest extent permitted by law.

Association and all of it's participants/players shall strictly observe and comply with all safety laws, rules and regulations (including but not limited to the Federal Occupational Safety and Health Act, the New York Labor Law, and all regulations promulgated pursuant to such laws) and to provide such protection as necessary to protect its workers and the workers of other associations. In the event that additional safety measures are required, Association and all of it's participants/players agree that it will install or procure such additional safety measures at its sole expense. To the fullest extent permitted by law, Association and all of it's participants/players shall hold harmless, indemnify and defend Town of Irondequoit against all losses, claims, fines, or expenses, including but not limited to attorney's fees, resulting from the enforcement of these laws and related acts of its officers, employees, subcontractors, suppliers, and materialmen.

### **Athletic Field Guidelines**

1. Reservations will be made on a first come first served basis.

Reservations are not confirmed until full payment is received. An invoice will be issued to temporarily hold your reservation; however, if payment is not made in full prior to the reservation date, the booking will be cancelled.

2. Refunds will not be granted for rentals that are cancelled less than 10 business days before the rental date or if the rental is cancelled after it has started. NOTE: The reservation may be transferred to an alternate date at the same facility or a different but comparable facility (if available) within 3 months of the original date.
3. Facility reservations cancelled by the Town or cancelled due to inclement weather will either be rescheduled as availability allows or will be refunded in full.
4. If thunder and/or lightning is observed during field use, responsible renter shall immediately cease play, wait for 30 minutes and re-evaluate the situation. If thunder/lightning persists then postponing and canceling will need to occur.
5. No team practices or leagues of any sort are to be allowed on Town fields without following the proper procedures for securing a reservation.
6. To be considered a resident, 50 percent of team rosters will be required to reside in the Town of Irondequoit. Rosters with player names, addresses and phone numbers will need to be provided. For youth teams, parent/guardian names will be required.
7. The renter must provide proof of liability insurance policy in the amount of \$1,000,000 and name the Town of Irondequoit as additional insured.
8. Games may not begin before 8:00 a.m. All games must end by 10:45 p.m. All lights will be turned off at 11:00 p.m.
9. Daylight hours are defined as 8:00 a.m. to sunset. The use of field lights will turn on once sunset has occurred.
10. The Recreation Department may refuse rental to anyone. Reasons may include but are not limited to; non-payment, abuse of facilities, sportsmanship issues, lack of supervision, and disregarding policy, etc.

#### **Athletic Field Guidelines Continued**

11. Organizations, team coaches and field renters are responsible for the actions of all individuals, including spectators, during the time of field use. Verbal abuse or physical abuse will not be tolerated and should not be directed to anyone whether it be a game official, spectator or player.
12. Parents or Legal Guardians are responsible for the behavior of their children at all times during field use.
13. Field sizes are set and are not negotiable. No painting, marking or altering of fields.
14. No pets are allowed on the athletic fields.
15. Alcoholic beverages, drugs and smoking, including e-cigarettes are prohibited at all facilities.
16. Entry fees may NOT be charged for sporting events.
17. Commercial advertising is NOT allowed on Town fields.
18. No gum, seeds, food, or beverages are permitted on the McAvoy Park turf.
19. No outside concessions or merchandise will be sold on rental facilities without Town consent for an additional fee.
20. Field rental availability- Mid April-November. Dates are subject to change, weather permitting.
