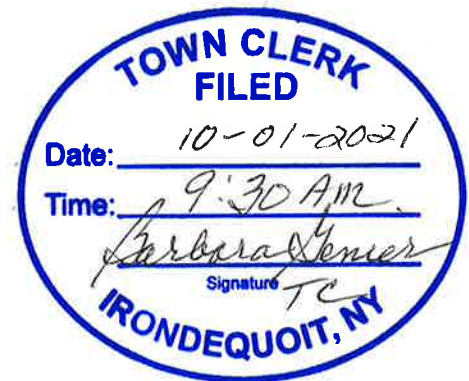

NOTICE IS HEREBY GIVEN that the Proposed Budget of the Ridge Culver Fire District of the Town of Irondequoit, State of New York, will be presented to the Board of Fire Commissioners of the Ridge Culver Fire District, for its consideration at a public hearing which will be held at 6:00 p.m. at Ridge Culver Fire Station, 2960 Culver Road, Rochester, New York 14622, in the Town of Irondequoit, State of New York on October 19th, 2021. Immediately following, a Public Meeting will be held to adopt said budget.
